## REGIONAL CANCER CLINICAL LEADS GROUP (RCCLG)

### **TERMS OF REFERENCE**



#### **Role / Purpose**

The RCCLG will work across the west of Scotland in conjunction with regional, national and international bodies to:

- Ensure the development of best practice in the prevention and management of cancers in accordance with Beating Cancer: Ambition and Action, Scottish Intercollegiate Guidelines Network guidance, NHS Healthcare Improvement Scotland standards, Quality Performance Indicators (QPIs) and any other relevant recommendations.
- Promote equity of access to cancer treatment and care across the region.
- Facilitate a coordinated and collaborative approach to the planning and delivery of safe, clinically and cost effective cancer care to patients in the west of Scotland.

### **Objectives**

- To drive innovation, and inform/shape new models of cancer care.
- To act as a forum for discussion of current and proposed new treatments and services, including their efficacy, effectiveness and resource implications.
- To promote consistency in the application of, and equitable patient access to, current evidence-based best practice.
- To consider QPI findings and provide assurance to the West of Scotland Regional Cancer Advisory Group (RCAG) that appropriate action plans are in place to address issues identified and that actions are being progressed.
- To provide advice and make recommendations to the RCAG, West of Scotland Health and Social Care Delivery Plan Programme Board, NHS Boards and Managers on all aspects of cancer care including, for example:
  - Prevention and early detection
  - Access
  - Treatment
  - Care after treatment
  - Research and development
- To influence and inform a regional/population approach to the development, planning and delivery of cancer care across the west of Scotland.
- To identify issues that could be effectively advanced regionally and/or nationally.
- To develop, agree and monitor progress of an annual regional cancer network work plan.
- To ensure clinical recommendations are communicated to appropriate groups and are acted upon accordingly.

#### **Responsibilities of Individual Group Members**

- Each member will be responsible for ensuring s/he reflects the views of their NHS Board, Network or regional sub-group at meetings.
- Each member will be responsible for timely communication between their Health Board, Network or regional sub-group and this group.
- Each member will actively contribute to the work of this group.

• Each member will identify a nominated deputy to attend meetings that they are unable to attend, ensuring representation from relevant Boards, Networks or regional sub-groups at all meetings.
